



What do I do if a student tells me about relationship violence, sexual assault, stalking, or sexual harassment?

Students may share their experiences in various ways: through assignments, class or workplace discussions, email, and more.

Express Support

The most important thing you can do is listen and help them feel safe and supported. Here are some ideas of what you can say:

"I care about you and am here to listen or help in any way I can."

"I'm here to listen and support you."

"I believe you."

"It took a lot of courage to tell me about this."

"I know this is hard to talk about."

Remember:

It's not your job to find out details about what occurred. **Avoid asking questions such as:**

X "Why were you there?"

or

X "Had you been drinking?"

This may make the student feel judged or blamed.

Offer to Help Connect With Resources

Knowing what resources are available can help someone along their path to healing. Gently ask the student if they are interested in learning about supportive resources. Offer to connect them with trained professionals who can help or offer to visit supportmore.msu.edu with them to learn about what services are available.



Explain Your Role as an MSU Employee

It's important to be transparent about your obligations to report incidents as an MSU employee. "Because of my role at MSU, I'm required to share what you've told me with the Office of Institutional Equity and MSU Police. They will listen to what you want to happen next and honor your decisions, as long as you and others aren't at risk or in danger. Even if there is no formal investigation, there may be things they can do to help you feel safe and continue to succeed as a student here at MSU."

When possible, ask if the student would like to fill out the online reporting form with you, so they are aware of what is being shared with the university.
